
I had just landed in the Fort Lauderdale, Florida airport when a man with a gun opened fire. A bullet pierced through my backpack, hitting my laptop -- and sparing my life.

My shooter was on the record as a domestic abuser who strangled and beat his girlfriend, and he'd been flagged for serious mental health issues. And yet he reportedly had his gun returned to him and was able to check it as his only baggage on a one-way, cross-continental flight without any red flags. According to reports, he *legally* carried the gun in public with a concealed carry permit before taking the lives of five innocent people shortly after arrival in Fort Lauderdale.

Now, Congress is considering an extremely dangerous NRA policy -- something they're calling "concealed carry reciprocity" -- that would let people like my shooter legally carry a hidden, loaded gun in all 50 states.

We can't let Congress gut our gun laws, Pamela. But we can only stop this dangerous NRA policy if every single one of us speaks up.

Send personalized postcards to your lawmakers and tell them: Don't gut our gun laws. Vote NO on concealed carry reciprocity. Help us flood the offices of Rep. Meehan and Sens. Casey and Toomey with the voices of everyday Americans.



I never thought something like a shooting would happen to me. But the fact is that gun violence in America is far too common due to weak laws that allow dangerous people to get their hands on guns.

In 31 states, law enforcement has the power to deny dangerous people a permit to carry a hidden, loaded gun. People like convicted criminals, domestic abusers, or people with a concerning mental health history. People exactly like my shooter.

But if the NRA pushes concealed carry reciprocity through Congress, state and local law enforcement will be completely stripped of that power. Pennsylvania will have to recognize permits from states with low or even no permitting standards whatsoever -- and then there'd be nothing to stop these dangerous people from carrying hidden, loaded guns on your streets. It's a major step towards the NRA's ultimate vision of more guns in more places for more dangerous people, no questions asked.

We can't let that happen, and that's why we need everybody to speak up. <u>Send Rep.</u>






